

GENERAL TERMS AND CONDITIONS

MINIMUM ORDER:

No minimum order required. Check our stock before placing your order. Workable product displays are available to become a stocking distributor. Call Sales Department of Corona Lighting for initial order.

TERMS OF PAYMENT:

Net 30 days from date of invoice upon approved credit. Past due accounts are subject to service charge of 1.5% interest per month (18% per annum). The buyer agrees to reimburse Corona Lighting for all incurred collection costs and legal fees which are necessary to enforce payment of invoiced amounts. The proper venue for any dispute arising from overdue payments shall be any court of competent jurisdiction in Los Angeles, CA.

RETURN POLICY:

All returned products must be accompanied by a "Return Goods Authorization number" (RGA #). Please contact Corona Lighting Customer Service Department for RGA #. All returned products must be approved by Corona Lighting. Returned products are subject to the following conditions:

- Freight must be prepaid by buyer.
- No product may be returned, if purchased more than a year from date of invoice.
- No custom made or discontinued products will be accepted for return.
- Returned products must be new and packed in original sealed factory box.
- A minimum of 30% restocking charge will be made on returned products, except for products approved by Corona Lighting to be defective in material and workmanship. Corona Lighting is not responsible, nor does it guarantee credit or replacement, for any returned product without RGA #. Any returned product without RGA # will be refused.

PRICE POLICY:

All prices and terms are subject to change without notice. All orders will be shipped at prices prevailing at the time of shipment. Written proposals and quotations are firm for no more than 30 days, unless otherwise stated in writing.

FREIGHT POLICY AND CLAIM:

All Shipments are made FOB Los Angeles, California.

Claims for shortage and inaccurate filling of orders must be made in writing to Corona Lighting no later than 5 days from receipt of shipment. Title and risk loss pass to buyer upon delivery to carriers. Freight carrier and method of shipment and routing shall be at Corona Lighting's discretion. All claims for shortages and losses relating to transit, concealed or apparent, must be filed with the carrier immediately. Additional charges for shipping via special carriers as requested by buyer will be added to invoice.
